CNAS' subsidized price as their refund plan contracted with the House is already two times surpassed.

In the end, affording it becomes the most important thing for an insured person who's realizing the insurance hardly covers anything. Under these circumstances, it no longer comes as a shock, the case of the TBC underprivileged citizen who died a couple of years ago, in an ambulance, while being passed around between five different hospitals not willing to accept him as a patient. Finally, he was left by the ambulance personnel on the same sidewalk from where he was taken, where concerned citizens had called the ambulance to help him, in the first place. Unfortunately, the medical system failed to deal credibly with the situation

Bucharest downtown. A modern building, with expensive cars in front. Inside the clinic, no chlorine smell, no water infiltration on the walls, but a lovely young lady at the front desk managing the appointments of the day. On three floors, several doctors receive patients. Two state-of-the-art laboratories are located at the lower floor. The clinic is a private business, and here your social health insurance policy will only buy you just a polite greeting. To access the medical services you need to purchase them directly from source. All major companies in the country are subscribers to such a luxury private medical service providers: for a fee, often larger than the average national wage, their employees are 24 hours a day, seven days a week pampered by qualified personnel. Most of the doctors here are the same with those working in the public hospitals (no private general hospital is available in Romania, at this time). Just imagine who's more likely to get FIRST their undivided attention...

Nevertheless, there are also many private clinics which manage to successfully collaborate with the public health insurance system, for the benefit of the public. Their services - like in the case of Euromedic clinics, are fully covered by the public insurance system, thus the access of all citizens being assured.

George finished his round for the night in the ER. He works for the public hospital service, but he also has an individual contract with a well-known private clinic in Bucharest. He has no medical cabinet there, but nevertheless he is one of their surgeon doctors: in special cases or accidents, the clinic's luxury patients will be operated by him, in the public hospital's ER where he works. The clinic has some kind of location contract signed with the hospital, which gives it the permission to use the hospital amenities and VIP reserves for the private clinic's patients. "Of course, it is always easier to fight sickness when you have all the help available, said George. But in the end, against death, all people are equal". Definitely, a philosopher this George!
